**HOTEL ACCOMMODATIONS:** If not deemed eligible by DPAA to stay in the Mayflower Hotel, reserve rooms at the nearby Churchill Hotel by calling 202-909-2129, noting affiliation with the National League of POW/MIA Families, or go online to <a href="https://www.thechurchillhotel.com">www.thechurchillhotel.com</a>, and enter **POW/MIA Families** to get the special rate of \$169+tax, per room night. The cutoff date to get the special rate is **June 14, 2024.** The number of rooms is limited, so register early to assure your choice. The Churchill Hotel is located at 1914 Connecticut Ave., NW, Washington, DC, 20009, about a mile walk from the Mayflower Hotel and a bit over a mile, or one Metro stop, to The American Legion Building.

**Opening Session** is Wednesday, June 26th,1:00 PM, with the **No-Host Reception** on the Mayflower Mezzanine at 6:00 PM, followed by the **53rd Annual Meeting Dinner,** District Ballroom.

**DPAA-hosted Vietnam War Annual Government Briefings** (AGB) will be held at the Mayflower Hotel beginning at 9:00 AM on Thursday and Friday, June 27th and June 28<sup>th</sup>.

DNA Samples Needed. Family members who have not yet provided a **DNA** sample are urged to do so. Check with your Service Casualty Office (SCO) at the Mayflower Hotel to determine eligibility.

The League will host **Live-Streaming Parties** to virtually watch the Vietnam War AGB both days, in the 7<sup>th</sup> Floor Ballroom of The American Legion Building. A casual lunch will be provided each day and a **Happy Hour will be held on Thursday**, **5:00 – 6:00 PM**.

On Saturday morning, June 29th, the League will host a **Q&A Forum**, followed by a very important **League Business Session**, open to all registered attendees, again in the 7<sup>th</sup> Floor Ballroom of The American Legion Building. (You must be a dues-current League family member to vote at the Business Session, but all are welcome to attend.)
